**DOI Fabrica Form.** Earlier this year we announced a beta version for creating and updating more metadata through the [DOI Fabrica form](#). In addition to the required properties, you can now also add all of the recommended and optional properties. This includes related identifiers, subjects, funding, geolocation, and more. This month, we are excited to announce that we have taken this feature out of 'beta' so it is officially ready for use!

How do I update my contact information?

DataCite Fabrica is where information about DataCite members, consortium organizations, and repositories is stored. There are four types of accounts in Fabrica: Direct Member, Consortium, Consortium Organization, and Repository. You must make sure your contact information is correct and kept up to date for all of these accounts in order to receive communications from DataCite. You can add contacts to your Fabrica account when you log in by navigating to the "Settings" tab. Click on "Update (Member/Organization/Repository)" and add your organization's "Service Contacts", "Technical Contacts", and "Billing Contacts" click "update" at the bottom of the form to save.
